## Party in the Park!

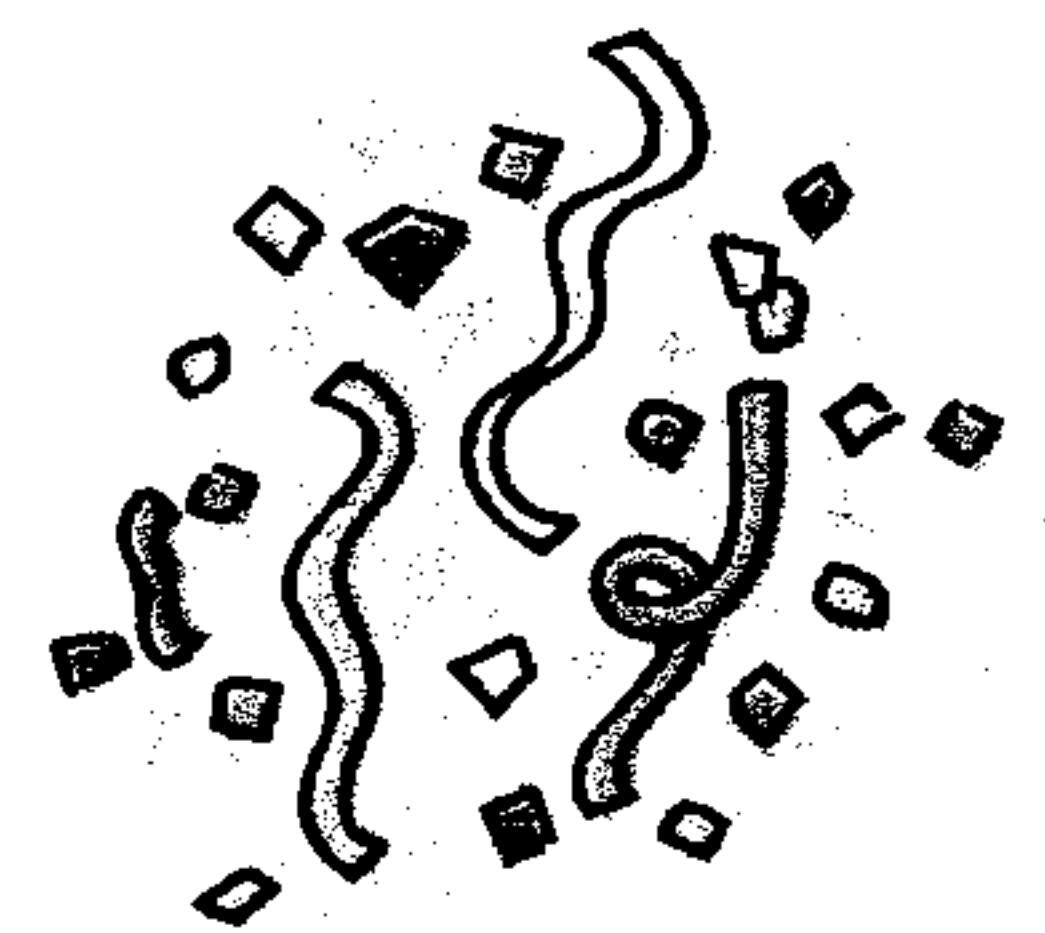

# CORONA DEL MAR PARK

As always we couldn't send out a Herald without a reminder of being courteous at the Park. This means PLEASE pick up after your dog and the current Rules permit 2 dogs per person at the Park. Vidal, our gardener, has really been working hard to improve the overall appearance of the Park. We think he's doing a great job! But sadly, picking up after Fido has become part of his job requirement and this costs all members. Because those who refuse to clean up after their dog, Vidal comes an

extra three times per week to clean up after them. This costs the association an additional \$150 per month (\$1800 annually).



Also, it appears we may have a thief; doggy bags which are provided by the association seem to be mysteriously disappearing at an accelerated rate .....hmmm, Vidal is coming more often, yet we are replacing the doggy bags more frequently, something doesn't smell right...no pun intended!

An unleashed dog must be leashed upon request. Use common sense ....should you see a child or an elderly person, be mindful of their presence. If they are uncomfortable with your dog, please leash Fido even if they don't ask you.

The Park Rules are currently under revision, and will be mailed out soon.....

There have been new door knobs installed on the gates at the Park. It should go without saying, we trust no one will take them this time.

We expect EVERYONE to follow the Rules. If your dog does not have a HP Dog Tag, you may be cited by our Security Patrol. Tags are \$10. ## ARCHITECTURAL REQUIREMENTS

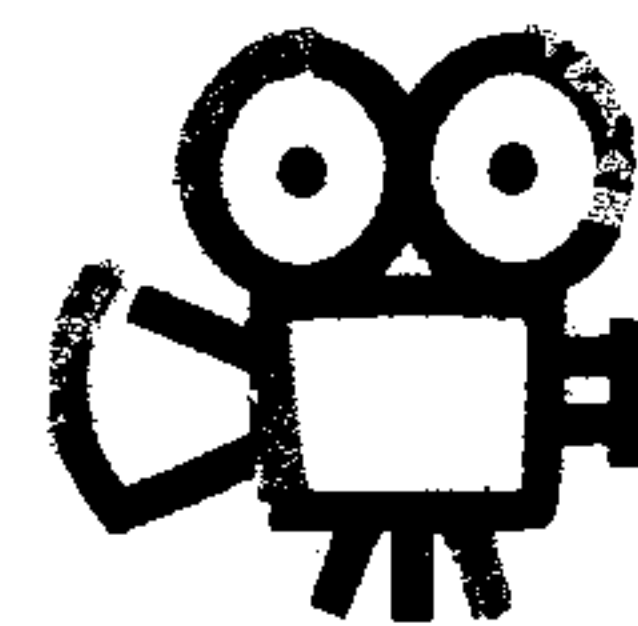

## THINGS YOU MAY NOT CARE ABOUT, BUT THERE WAS SPACE TO FILL

- Construction Permits issued by the HPPOC ARC are effective for one year. If you don't begin construction by then, you are required to request an extension in writing .
- Check out a contractor before you hire them. Call the CA State License Board (CSLB) at 800-321-2752 or [www.cslb.cs.gov](http://www.cslb.cs.gov) to check the status of license & insurance.
- By calling the Global Mobile #112 your cell phone is able to use any available cell tower to call in an emergency situation, even if it's not your carrier. This it only works if your phone has service (bars). Confirmed on snopes!
- To reach any LA City service, dial 311, a live body will answer & connect you to with the right department if they can't answer your question.
- Stop solicitor calls by registering your land & cell phone numbers with the National Do Not Call Registry. This is good for 5 years. 888-382-1222 or [www.donotcall.gov](http://www.donotcall.gov)

# FILMING IN THE NEIGHBORHOOD



The Board adopted the new proposed Film Rules that were distributed at the end of November, effective January 14, 2008.

We received two letters during the 30 day response period, which were discussed and considered before approval.

Filming in our neighborhood keeps the industry in California. Please be respectful of those who are inconvenienced and not receiving the "additional income" as you are. The fees charged by the Association for filming within the Huntington

Palisades are used to help monitor the issuance & denial of film permits & implementation of our rules.

Please remember that if you are approached by a location manager, you are required to inform them that you are a part of an association and there are Rules and Fees in addition to your own.

There are many neighbors that don't like filming at all, so please be courteous when making the decision to allow filming at your home. The newly

adopted Film Rules are available to download online at [www.hppoc.org](http://www.hppoc.org)

Here are some quick rules:

1. Filming hours 7:00am—10:00pm
2. No filming on weekends, holidays or any Fridays in December.
3. Food must be eaten and prepared out of public view.
4. Parking is on one side of the street only.
5. You are allowed to film 2 times per year and 10 aggregate days (or portions there of)
6. Filming Fees: Prep & Strike: \$500 per day; Still Shoots: \$500 per day; (\$250 for 1st 3 stills)

Filming: \$1000 per day

## Sale of Your Home & Escrow Docs!

Once again in 2007 several homes were sold in Huntington Palisades and for what ever reason the owner did not disclose they belonged to a mandatory Association. Once we discover a home has been sold, without escrow calling us for docs, we are forced to pull a title search. Unfortunately the end result usually causes discomfort between the new owners, sellers and the escrow agent. Don't deny potential new homeowners the positive experience of moving in Huntington Palisades, most people are happy to belong to our Association and community. In order to avoid this lengthy and often costly process, please notify the agent and escrow company that you belong to an Association.

We also perform a monthly drive through and review the Post for homes for sale. Letters are mailed to the sellers and realtors reminding them to notify the escrow agent their home belongs in a mandatory association. This makes it more surprising when homes slip through the cracks!

The Association transfers your title information and gives important documents and current rules to the new owner(s). This is the way to keep our resident list current and billing in order.
